LOCAL HUNTING OPPORTUNITY

RANGE AND SHOOTING



WAIRARAPA BRANCH Antler, Horn & Tusk competitions for year to 30 September 2019 and including Photographic competitions for the same period.

All competitions will be run closely to the Branch Competition rules which have been laminated and displayed in our Parkvale meeting room for the whole competition year. These notes are simply an abbreviation of them.

Key dates this year are:

• Closing date for the taking of heads, jaws and photos is **Monday 30 September 2019**.

- Entry forms and AH&T Trophies (heads) to be in the hands of Greg Hamilton (King and Henry), or Joe Hansen (phone 027 692 6465), by **noon Tuesday 1 October 2019**.
- Photographs to be with Tracy Amos (06 3795454) by **noon Tuesday 1 October 2019**.
- Entries can also be dropped off at the General Meeting 7:30 pm Parkvale Hall 18 September 2019
- Branch Prize-Giving presentation of Awards & Certificates Saturday 19 October 2019.

Extracts from the Rules.

- 1. Entrants must have been financial members of this branch at the time of shooting the trophy or taking the photograph. Junior members (18 yrs & under) to be noted on Entry forms please.
- 2. All entries in the Antler-horn-tusk competitions (including the Paid hunting section) must have been taken in unimpeded fair chase. No spotlighting. Paid hunting entries are to be clearly designated on Entry forms.
- 3. Antler-horn-tusk entries must be on a clean, full skull (or jaw). Foul entries will not be accepted.
- 4. A Disputes panel will be appointed by the Committee.
- 5. A competitor may enter more than one head in each competition.
- 6. Entry forms (both AH&T and photographs) should contain adequate information to illustrate the philosophies within these Competition rules are met.
- 7. Photos taken in N.Z. Not from a Conveyance. No dead animals or birds. Maximum size for prints is 7" x 5" (175mm x 125mm).
- 8. Judging will be of four categories. The categories must be designated by the entrant and clearly marked on the Entry form and the back of photo. One fully completed entry form (see note 6 above) for each photo. Members may enter up to three photos in each category.
- 9. The categories are:
 - a. Game animals in their wild, outdoor state. Not in any form of captivity.
 - b. Other Wildlife in its wild, outdoor state and not in any form of captivity. The subject matter is to be relevant to hunting, hunting country, and the associated activities of hunters.
 - c. Scenic relative to the sport of hunting. Human activity should be of minor importance.
 - d. Other not covered in other categories. Subject matter is to be relevant to hunting or hunting country. Or the associated activity of hunters.

NOTE: The winning photo of each category will be retained for the Parkvale Hall display board.

Entry form at the end of the newsletter. There must be a separate entry form for each trophy or photo submitted!

NATIONAL OFFICE NEWS

National Competition Entries

National Antler, Horn & Tusk and Photographic competitions are now open. Entry forms, Douglas Score sheets, photographs and payment must be at the National Office no later than 5 pm on Friday 26 July 2019. Entry forms are available by e-mailing wairarapanzda@gmail.com. Bearing in mind the membership problems, NZDA will honour membership for 19/20. This means that any renewing member who has paid and is still waiting for a membership card – your membership will be honoured from the date of your 19/20 invoice payment.

FIREARMS MODIFICATIONS & BUYBACK

Police are currently designing the process for engaging gunsmiths approved to undertake this work, in accordance with the new firearm regulations. As it stands, Police have not approved gunsmiths under this scheme. Once the appropriate process has been finalised, Police will release the details for gunsmiths to apply to be approved for the purposes of this scheme.

Continue to store firearms safely as we work through this process. Police have spoken to several gunsmiths who are receiving firearms for modifications, even though they are not currently approved, which is causing issues for them. There is no guarantee that firearm owners will be reimbursed for modifications that have been completed before the details of this process have been announced.

We are well aware of the impacts of this and we are working to address this issue as quickly as possible. You will appreciate how important it is that we get this process right. Police would like to thank the firearms community for their patience as we work to get this process in place.

COLFO ON FIREARMS LAW CHANGES

Many licensed owners are now aware of the value placed on the Prohibited Firearms and Magazine that you own and the process for handing them in. If not visit the Police website where you will find the details: https://www.police.govt.nz/advice/firearms-and-safety/changes-firearms-law-prohibited-firearms

For some of you the prices offered are fair and reasonable, for others they are far below what one should expect. For parts you only get 70% of their value even if brand new. There is no compensation for now redundant ammunition, reloading tools, accessories, security, safes and so on which is a gross injustice. Further, if you wish to retain any of the newly prohibited items you are required to apply for a NEW endorsement at a cost of \$204.

COLFO is planning to take legal action, likely to be by way of a class action and will be seeking financial assistance from all licensed firearms owners. Legal action requires careful planning and cannot be rushed. There are more legislation changes on the horizon and we would be foolish to act now before the full portrait is complete and on show. There is a possibility that with enough funding, we can take up multiple issues through the justice system. We will be requesting contributions soon, we are in the process of setting up the best way to receive funds for our legal fights. This will be set up so that it benefits the majority of firearm owners rather than individual organisations. We need hundreds of thousands of dollars for the litigation ahead and we need it from you, our community. It is so vitally important that we all come together on this and we all back each other through this process.

A reminder that while your emotions are being tested, please be cautious in what you do and what you say, especially on social media. Some comments are inviting the attention of police and media when rashly stating they may take unlawful action. The Amnesty has 6 months to run until 20 December, there is time to take what steps you deem necessary.

We are concerned that the first collection event in Christchurch on 13 July may become a media circus. Attending this event could pose risks for both your emotional and physical wellbeing and by being identified potentially put your future security at risk. You have 3 other options for handing in your firearms.

Many in our community are feeling stressed, first by the sudden new legislation, then by the loss of their hobby or sport and now by the confiscation of their property through no fault of their own and compensation falling short of being fair. Look out for your mates and talk the issues through with friends who understand. It is important that we unite as one and that means backing each other up and being there to support friends and families. Utilise others in your community for help if you need to.

Please forward this to you shooting mates, clubs and associations.

LOWER NORTH ISLSND RED DEER FOUNDATION

We have had a mostly constructive year in terms of the long running Ruahine Deer Plan process and an at times busy year in regard to the still going 2018 WARO (Wild Animal Recovery Operations) review.

The Ruahine Deer Plan was into the meaty issues of resource allocation and alternative control regimes, additional monitoring and indicators to allow fair assessment of deer impacts and identify if and where additional control is needed. Everyone is still talking and want to push on. In the meantime the old status quo closure and restriction regime remains. Resourcing issues for DoC have caused there to be some confusion as to future progress so currently (mid-June) we are uncertain where it will head.

That the 2018 WARO review has been farcical is about the kindest I can be. Set appalling timings the local DoC offices and hunters did their best only to be stabbed in the back by a faceless national team trying to open nearly everything. We await the outcome of the Feb submission process. The Foundations lawyers at our request have put DoC on notice that we will take them back to court should they continue to ignore the courts decision in regard to some local areas.

I became involved in the Tahr issue in September last year as a co-opted member of the Tahr Foundation. Our small group thanks in large part to the help of the Duley's and their production team and all the guys who moved our material via facebook and all those who donated (\$200K) managed to get the attention of the Government and the minister. Her extremist plan to all but wipe out the tahr was knocked back by people power to something more reasonable. The control plans are still evolving and no one should be under any illusion that the tahr are safe.

Interesting to note that the worst approaches to consultation (WARO, Tahr, Firearms) about changes is from a government which marketed itself is being for increased consultation and giving the people a say. Talk is cheap.

We have had a range of other issues to contend with including Firearms legislative changes, OIR system review, various regional policy reviews and so on. No doubt there will be more firearms law change proposals in the near future. One thing that adds some light to the end of the tunnel is a recent decision by the National Animal Welfare Advisory Committee (a Ministry of Primary Industries committee) to note that best practice for aerial 1080 operations would be to include deer repellent. This makes 1080 operations without deer repellent easier to challenge. Well done Gary H.

BETTER UNDERSTANDING THE KEY TO RECREATIONAL ACCESS

WorkSafe NZs recent policy clarification regarding the Health and Safety at Work Act and the current Walking Access Act Review are timely initiatives that will help preserve New Zealanders access to recreational opportunities, according to Game Animal Council Chair Don Hammond.

"The ability to responsibly access public conservation land and other recreational assets is a key part of what make New Zealand a haven for outdoor enthusiasts," says Hammond.

"Unfortunately, over recent years we have seen this access threatened as visitor numbers have increased, public behaviour has at times not lived up to expectations and uncertainty has existed over the responsibility provisions within the 2015 Health and Safety at Work Act."

The Walking Access Act Review gives hunters and other outdoor recreationists the perfect opportunity to identify barriers to access as well as giving landowners the opportunity to explain the challenges they face providing for access in certain circumstances.

"It is our hope that this process will lead to better understanding of the issue from both sides of the fence and it is therefore very important that as many hunters as possible take part in the Review. The Game Animal Council will also be submitting on behalf of the sector."

The Game Animal Council is extremely encouraged by the recent policy clarification that has come out of WorkSafe NZ regarding how the Health and Safety at Work Act should be applied to recreational access. "The clarification quite clearly removes the uncertainty that has led to the erosion of public access to recreational opportunities in a number of locations around New Zealand."

WorkSafe has found that the Health and Safety at Work Act only applies to recreational access when that is affected by workplace activities or is part of a workplace. This means a landowner whose property is being accessed for recreation is only responsible for risks arising from the work or workplace, and is not responsible for the risks associated with the recreational activities.

"The clarification is very clear that landowners, including farmers are not expected to manage the risks from recreational activity on their land."

"The Game Animal Council is grateful to those organisations that sought this clarification and we look forward to a better understanding of responsibilities and the enhancement of public access as a result. The Game Animal Council also encourages both landowners and users to advise each other of any hazards as safety is not just driven by legislation, but is ultimately everyone's responsibility," says Hammond.

The Walking Access Act Review's public submission process closes on 2 July and is available at https://www.mpi.govt.nz/law-and-policy/legislation/walkingaccessreview/.

A couple of good ones from the 2019 roar By Brad Gardiner

For the 2019 roar there was a bit more pressure on me than usual as I was going to be short on time and the property that I have been hunting for the last ten years had been sold so wanted to make the most of it while I could.

It is a place that I could hunt as I liked and mostly had to myself so could manage the herd. When I started there was only a handful on the place and most of them where young stags and bugger all hinds. By leaving

them alone and only taking rubbish type stags out I have been surprised how quickly the herd has built up and with a bit of age on them produced some respectable heads. But that has all changed now as it has fallen into the government loophole of overseas investors buying up our farming land to plant into trees.

I had been watching a good sized mob of stags during velvet time on a scrubby face growing out so knew there was two reasonably good ones amongst a lot of younger ones. There was also a fallow buck hanging with them from time to time which was unusual as there is next to no fallow around this area.

The start of April rolled around and I started heading over there scouting it out for a good one but only bumping into hinds and young stags. On the first weekend of April a mate Damian and I were up there for a look and a listen when we heard our first roar. It wasn't where we intended to hunt so left it to it and headed out the back. When we got out there all was quiet and we only had seen one hind and its fawn so were thinking we had made a bad move. I let out my first roar for the season and listened and waited. Nothing. Maybe a couple of minutes passed then I happened to look down the hill and there was that fallow buck sneaking up to us for a look. A quick whisper between us had me make my mind up that I was going to take him. A front on shot and down he went kicking out and sliding down the hill. We had a look around the face with our binos in case the shot spooked out a hiding stag but nothing showed. Down to the buck we went and I was pleased with our decision. A nice respectable animal.

A couple of days later I headed back for an evening hunt to try and catch up with that stag we had heard. I headed up the gully and headed straight to where a wallow was and as I expected it had been used. I let out a roar and got an instant answer. He was on the ridge above and to my left. He was instantly on the move but doubling around behind me. I was worried he would come back and down and cut my sent so shot back as quickly as I could to cut him off. I got there well before him and it gave me time to get set up in a good position and let out a little moan to direct him to me. It worked and he came zigzagging down the face stopping to roar a couple of times as he went. I had borrowed a mate's 6.5 creedmoor to have a play with so wanted the stag to get reasonably close to take the shot as I was unfamiliar with the rifle. It also gave me a good chance to assess the stag to see if it was a shooter. I also have my gopro on in these situations and have caught some good footage over the years. I let him get to about thirty meters and by then I had made my mind up I was going to take him so took a shoulder shot. The shot was good and down he went but after thirty seconds or so he was trying to get up but ended up sliding down the hill towards me which made an easy follow up shot into the neck to seal the deal (I always stay for a minute or two where I am with rifle ready for such situations like this. Particularly with roaring stags as they can take a bit to keep down). So it ended up being a good couple of days hunting with a couple of heads and plenty of meat to deal with.
