#### NATIONAL OFFICE

It has been in the past, the norm to provide much background into what is happening nationally of interest to members in our newsletter, however, NZDA National Office has really stepped up its information flow both with media releases and providing more detail and links in monthly newsletters.

These are now popping up in emails on a more frequent basis – we encourage you to open and read these, and for three very important reasons:

- 1) for years we have sought stronger advocacy from NATEX on matters we deem important especially access, animal control and pesticide use, and firearms law and safety
- 2) we now have action as well as an executive officer who is also taking this advocacy to heart and his messages to us and to the rest of NZ are on point and needed as of right now
- 3) it is what we pay for as members, the "goods and services" from National Office are not free and we should appreciate and provide feedback when need be.

So please don't leave these communications unread in your inbox, keep up with what's happening and send feedback to us or NATEX as need be. Of course, for those of you tuned in to Facebook, you can follow NZDA on there as well.

Some highlights below .....

#### **Branding refresh**

Did you notice the new logo on the front page of the newsletter?

As part of our push to modernise our Association, over the past year the National Executive engaged a media consultant and branding expert, Leverage. The result is a suite of new logos, fonts and styles fit for our times. Our new Chief Executive Officer, Gwyn Thurlow, will oversee the delivery of our refreshed branding as well as the full replacement of our website. The official branding launch will occur soon, with the national website to be developed in 2020 over the coming months.

The Wairarapa Branch committee discussed the new branding. We agreed that it should be used on all

correspondence and clothing going forward. This will help promote the branch and national organisation in the eyes of the public.

#### Q: Why are we doing a brand refresh?

We want our brand to reflect the culture of our Association and to ultimately stand out. Our current brand identity has not kept pace with technology, and the brand refresh will mean it is fit for purpose across digital platforms and give us an opportunity to bring more consistency across the our branches and social media accounts. Our updated look is modern and fresh but is not a wholesale change to our existing identity. We are seeking to enhance what we already have.

#### Q: What will happen to the old branding?

We will launch the new branding in a sustainable way, which will mean that we will continue to use our existing stationary. Over time however, this will eventually be replaced. All digital formats will use the branding from August. The existing website will remain up until replaced with the new website (this will happen in 2020).

#### Q: What are the next steps?

NZDA National office will update its stationary, merchandise, IT templates and documents using the new branding. Branches can adopt it as soon as they are able. Branches will be given access to all the files, fonts and style guides.

#### Q: Can we order swag and merch?

Yes, NZDA will be reaching out to our existing Sponsors – Swazi and Stoney Creek – and get NZDA branded clothing. We are also considering taking orders for hats and t-shirts, subject to demand. Watch this space!

## Changes to the Arms Act which may affect you

The following information has been provided by NZ Police and gives more detail on the implementation of the recent law changes and how they may affect you. Please take the time to study these and take note of what applies to you.

New changes to the Arms Act have started to come into effect. Police is reaching out to you to share information on the changes and how they may impact you.

The changes will impact on firearms licence holders to a lesser or greater extent depending on your individual activities. The changes give greater transparency to what will be considered when a person applies for a licence. The changes are coming into effect in stages, with the immediate changes summarised below. More information on these and later changes can be found on the Police website. The website is the main source of information for people. It also holds frequently asked questions and will be regularly updated. We encourage you to visit the website to look at the changes in more detail. $\langle$ 

#### Summary of the immediate changes

- People seeking a firearms licence for the first time will be eligible for a five year licence only. Others who may have let their licence expire or surrendered their licence or had it revoked are also eligible for a five year licence. At the end of the five year licence and if they have retained their fit and proper status they then will be eligible to apply for a ten year licence.
- A small group of additional firearms are now prohibited, including those short (pistol-length) semiautomatic rifles that had been defined as pistols because of their shorter lengths, and centrefire pumpaction rifles with a detachable magazine or a non-detachable magazine capable of holding more than 10 cartridges. There are also new requirements for lawful possession of a pistol carbine conversion kit (which converts a pistol into a shoulder-fired firearm). An amnesty is in place against criminal prosecution for possession of the above noted items. Regulations will be developed to enable a new buy-back and this will be well publicised when dates are confirmed. We ask that if you have one of the prohibited items or a pistol carbine conversion kit, that you please safely and securely store these items. You can visit the website to find out if you are eligible to apply for an endorsement and permit to possess to retain and use these items.
- Endorsements for wild animal and animal pest controllers will have a maximum duration of 2 years and 6 months.
- Additional exemptions have been created for those who own or manage an agricultural business and there is a real possibility the commercial viability of the business would be detrimentally affected by wild animals or animal pests and they can only be controlled through the use of prohibited firearms.
- Visitors to New Zealand will no longer be able to buy and take ownership of a firearm for use during their visit (they can buy and export only). However, visitors can import their own firearm, and lease, hire or borrow another firearm.
- New and updated offences and penalties.
- A Minister of Police's advisory group comprised of both firearm-owning and non-firearm-owning people must now be established to provide ongoing advice to the Minister.
- The Arms Act is set to be reviewed again in 2025.

#### Note on future changes

More changes will be coming into force from December 2020, from June 2021, from June 2022, and from June 2023. #### **TARARUA 1080**

OSPRI New Zealand and the Department of Conservation are planning a combined aerial operation to target predators in the Northern Tararua Range during Winter/Spring 2020. This operation will help reduce the possum and rodent populations to prevent the spread of bovine tuberculosis (TB) and help protect taonga species populations.

The operation was scheduled to begin in June/July 2020, however due to delays caused by Covid-19, the operation is now scheduled to begin in August/September 2020. Timing of this operation will be weatherdependent. Please read this carefully, as it contains vital information about the operation. The operation will be using sodium fluoroacetate, also known as 1080.

# WAIRARAPA BRANCH Antler, Horn & Tusk competitions for year to 30 September 2020 and including Photographic competitions for the same period.

All competitions will be run closely to the Branch Competition rules which have been laminated and displayed in our Parkvale meeting room for the whole competition year. These notes are simply an abbreviation of them.

Key dates this year are:

- Closing date for the taking of heads, jaws and photos is Saturday 26 September 2020.
- Entry forms and AH&T Trophies (heads) in the hands of Greg Hamilton (King and Henry), or Joe Hansen (phone 027 692 6465), by **5 pm Sunday 27 September**.
- Photographs to be with Tracy Amos (06 3795454) by **5 pm Sunday 27 September**.
- Entries can also be dropped off at the General Meeting 7:30 pm Parkvale Hall 16 September 2020
- Branch Prize-Giving presentation of Awards & Certificates Saturday 17 October 2020.

Extracts from the Rules.

- Entrants must have been financial members of this branch at the time of shooting the trophy or taking the photograph. Junior members (18 yrs & under) to be noted on Entry forms please.
  Because of the Covid disruptions in 2020, the committee have agreed that entries will be accepted as long as members have paid their 2020-21 subscription before 31 July 2020.
- 2. All entries in the Antler-horn-tusk competitions (including the Paid hunting section) must have been taken in unimpeded fair chase. No spotlighting. Paid hunting entries are to be clearly designated on Entry forms.
- 3. Antler-horn-tusk entries must be on a clean, full skull (or jaw). Foul entries will not be accepted.
- 4. A Disputes panel will be appointed by the Committee.
- 5. A competitor may enter more than one head in each competition.
- 6. Entry forms (both AH&T and photographs) should contain adequate information to illustrate the philosophies within these Competition rules are met.
- 7. Photos taken in N.Z. Not from a Conveyance. No dead animals or birds. Maximum size for prints is 7" x 5" (175mm x 125mm).
- 8. Judging will be of four categories. The categories must be designated by the entrant and clearly marked on the Entry form and the back of photo. One fully completed entry form (see note 6 above) for each photo. Members may enter up to three photos in each category.
- 9. The categories are:
  - a. Game animals in their wild, outdoor state. Not in any form of captivity.
  - b. Other Wildlife in its wild, outdoor state and not in any form of captivity. The subject matter is to be relevant to hunting, hunting country, and the associated activities of hunters.
  - c. Scenic relative to the sport of hunting. Human activity should be of minor importance.
  - d. Other not covered in other categories. Subject matter is to be relevant to hunting or hunting country. Or the associated activity of hunters.
- NOTE: The winning photo of each category will be retained for the Parkvale Hall display board.

Entry form at the end of the newsletter. There must be a separate entry form for each trophy or photo submitted!
